The Real Price of Handling Compliance In-House

Self-Managed Programs Cost Businesses More Than Expected

The hidden costs of compliance violations are about three times more costly than the direct costs associated with implementing an effective health and safety program.¹ But even an inhouse EHS program is no guarantee you can avoid large fines and business disruption.



TIME LOST

It's difficult to estimate the true cost of an ongoing investigation because every business is different. But business disruption due to work stoppage and time taken off other tasks to resolve violations and meeting with regulators negatively impacts the bottom line. In fact, time-related losses are some of the most expensive businesses must bear.



EQUIPMENT LOSSES

When equipment is used improperly, it can fail. The cost to replace or repair damaged property and machinery due to misuse is an unexpected hit against budgets.



FINES

Even the most well-intentioned in-house EHS program can come up short during an investigation. And depending on the circumstances surrounding a violation, the business could be looking at up to a \$13,600 penalty.²





TRAINING

One of the most common struggles businesses encounter when implementing an EHS program inhouse is developing training that is both effective and engaging to employees. And in the event of an inspection and resulting violation, companies must bear the cost of bringing training up to date and then implementing it across the business.



OPERATIONAL EXPENSES
