

Sunset Stone



Sunset Stone started in 1970 in Castle Rock and has grown to service Colorado's front range. They produce and install manufactured stone veneer. Acquired in 2023 by TGP Capital Partners, TGP is a private equity investment fund which invests in well-managed, growing companies.

Prior to the Sunset Stone purchase, Hellman & Associates conducted health and safety compliance assessment of Sunset Stone for TGP. This process included on-site facility assessment, written program review, employee exposure assessment for silica and interviews with personnel. H&A provided recommendations to TGP for its purchase due diligence. Sunset Stone supported a culture of safety but it lacked elements of a comprehensive safety program to meet regulations. Following the purchase, TGP contracted for H&A's ASSUREDCompliance[®] program to ensure ongoing compliance and plant safety.
